Capital Campaign Update

- Kickoff was well attended (80) on Thurs., Apr. 3. Positive feedback from those who attended.
- Initial brochures are ready.
- We ended our contract with Advancement Partners.
- Meeting with benefactors will begin soon.
- Solicitors will be assigned names for who they will visit. Discussion followed.

Budget 2025-2026

- The Finance Committee made a recommendation to raise tuition to \$6500.T his will allow about 3.3% new money to be added to the budget.
- An explanation was given in regard to the budget line that includes administration and instructional salaries. The assistant principal and the bursar salaries have been moved to the administrative side of the budget report.
- Health insurance will be less then a 3% increase.
- Brent Goebel made the motion to approve the recommendation of the Finance Committee, Marty Diekemper seconded the motion. It was approved.

Salary Schedule 2025-2026

- Teachers will receive a 3%-3.5% salary increase.
- The teachers had requested a few items when considering salaries this budget year. These included:
 - \$1,000 added to the base Extra to the Master's degree \$200 added at Step 5
- The approval of the Finance Committee recommendation allows these items to be fulfilled.
